The Governor of Arunachal Pradesh is pleased to invite applications from the citizens of India for filling up 4 (four) posts of State Information Commissioner in the Arunachal Pradesh Information Commission which is likely to be vacated by 5th February, 2024 in terms of Right to Information Act, 2005 as amended from time to time, read with the Right to Information (Terms of Office, Salaries, Allowances and Other Terms and Conditions of Services of the Chief Information Commissioner, Information Commissioners in the Central Information Commission and State Information Commissioner and State Information Commissioners in the State Information) Rules, 2019, as amended from time to time.

The earlier advertisement vide No. AR-11/1/2023-Sect-1-AR dated 16.03.2023 for 1 (one) post of Information Commissioner is hereby cancelled and the earlier applicants may apply again, subject to their eligibility.

Eligibility Criteria:-

- The State Information Commissioner shall be a person of eminence in public life with wide knowledge and experience in Law, Science and technology, Social

Service, Management, Journalism, Mass Media or Administration or Governance.

- b. The State Information Commissioner shall not be a Member of Parliament or Member of the Legislature of any State or Union territory, as the case may be or hold any other office of profit or connected with any political party or carrying on business or pursuing any profession.

Term of office:-

The Information Commissioner shall hold office for a period of 3 (three) years from the date on which he/she enters upon the office or until he/she attains the age of 65 years whichever is earlier and shall not be eligible for reappointment.

Salary:-

Salary of the State Information Commissioner shall be ₹. 2,25,000/- PM (Rupees two lakh and twenty five thousand) (fixed) per mensem plus DA and other allowances from time to time subject to the adjustment of Pensionary / Retirement benefits availed by him/her, if any, as per the rule. The allowances and other conditions of services shall be regulated under chapter IV of the Right to Information (Term of office, Salaries, Allowances and other Terms and Conditions of Service of Chief Information Commissioner (CIC), Information Commissioners (IC) in the Central Information Commission, State Chief Information Commissioner (SCIC), State Information Commissioners (SIC) in the State Information Commission) Rules, 2019 as notified vide G.S.R.810(E) dated 24th October, 2019.

Age:- Below 65 years.

How to apply:-

Interested candidates shall submit their application in prescribed format as enclosed at Annexure-'A' along with testimonial at email id secy-part-arn@nic.in before 5 PM on the last date of closing the application. On submission of application, it will be presumed that the applicant has carefully gone through the Public Notice and relevant Act/Rules/Regulations and he/she agrees to abide with the same.

- i. The submission of application in electronic format is mandatory and the time of receipt of email would decide whether an application is in time or late.
- ii. Government servants:- Persons who are presently working under State or Central Government or other Organizations shall submit their application through proper channel along with copies of ACRs/APARs duly attested by the Head of Department/ Head of Office for last 5 (five) years along with Department/ Vigilance clearance. However, in case of selection and prior to taking oath, he/she shall be required to duly resign from the current post.
- iii. ST/SC candidates shall enclose Caste/ Tribe Certificate (s) issued by the Competent Authority along with the application.
- iv. Integrity/ Character and Antecedents:- The integrity of the candidates shall be beyond doubt and free from all types of criminal and other charges. However, the appointment of selected candidate shall be subject to verification of character and antecedents by the Police.
- v. Applicants shall enclose No Objection Certificate from the Deputy Commissioner of respective home districts and Capital Complex regarding no encroachment of

Government land.

- vi. Closing date of application is 15th day of February, 2024, 5 PM (Thursday). No application shall be entertained after the closing date.
